MEETING CALL TO ORDER: Following a Workshop from 5:00 p.m. to 5:30 p.m. for informal Commission review and discussion of potential interview questions, the Special Meeting of the Port District of South Whidbey Island's Board of Commissioners was convened on Wednesday, February 11, 2015, in the Port office conference room at 1804 Scott Rd. in Freeland, WA. As announced, the primary purpose of the Special Meeting was for District 1 (Freeland) Commissioner candidate interviews. Although the Meeting was of course open to the public, it was scheduled primarily for Commissioner candidate interviews and Commission discussion, and public participation was not on the Agenda.

Commissioner Curt Gordon, President, called the Special Meeting to order at 5:34 p.m., followed by the Pledge of Allegiance.

- 5) Do you have the time to be a Commissioner?
