PLEASE READ - RULES & REGULATIONS

Camp Site Fees: (Self-pay, cash or check, payment drop box & envelopes on-site)

- \$25 With Power or Water
- \$20 No Power or Water
- \$5 Sewage Dump Fee for RV's, separate pay box at Dump station

Camping Rules and Regulations:

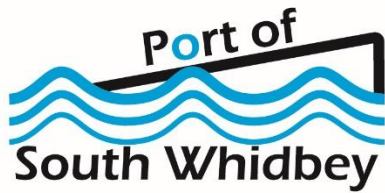
- Camp site spaces are first-come, first-served basis. No reservation system at this time.
- Per City of Langley laws, camping is limited to 14 nights within a 30-day period.
- Check-out time: 1:00 p.m. You will be charged an extra night if you occupy a camp site space beyond 1 p.m.
- You are responsible for maintaining a clean and orderly camp site space - clear of clutter and personal belongs strewn about. Clothes lines are prohibited.
- You are responsible to occupy only the camp space you have paid for. Limit two (2) vehicles per camp site space. Overflow parking is located north of the campground near the Fairgrounds buildings. If you are using more space than you have paid for, you will be charged for the extra space(s) you are using.
- Camping is only allowed in the designated camp site spaces within the campground.
- Speed Limit: 5 MPH at all times.
- No smoking allowed on Island County Fairgrounds and Campground property.
- Fireworks are prohibited. Firearms are prohibited.
- Fires must be contained in a metal container with water on-hand for emergency.

Campground Conduct:

- Drinking of alcoholic beverages are permitted only at your camp site space. It is against the law to have an open container in public spaces - no walking around the campground or Fairgrounds with open containers of alcohol.
- Behavior which disturbs or creates a nuisance for others in the campground or on the premises of Fairgrounds property are prohibited.

Failure to comply with these Rules & Regulations and Campground Conduct is cause for immediate eviction/termination of camping privileges with no refunds. Notification to City of Langley Police may occur, and is the sole discretion and judgement of the Camp Host and Property Manager. Please respect these rules so everyone can enjoy their stay! Thank you!

Maximum Occupancy Limits per Camp Site Space:

- One car and one Recreational Vehicle per space
- Two cars and two small to medium-sized tents per space
- Two cars and one large to extra-large sized tent per space

Garbage Disposal:

- Garbage cans are for paying campers occupying a camp site space, during their stay only. No dumping of large quantities of trash. You brought it in, you carry it out.

Sewage Dump Disposal - by order of the Island County Health Department:

- The gray water dumping station is on the southwest side of the campgrounds. \$5 fee per use. Gray water or sewage dumping anywhere else is prohibited, either from a holding tank or from containers. Violation of this law will result in immediate eviction and removal from Island County Fairgrounds and Campground.

Pet Control:

- Pets must be on a leash at all times; leash should not be longer than eight feet and owner should be in control of the pet at all times.
- Pet owners are responsible to clean up waste after their pet and properly disposed.

Quiet Hours:

- 10 p.m. – 8 a.m., seven (7) days a week

Restroom Facilities:

- Bathrooms and showers are available for all paying campers during their stay. After paying, please ask the Camp Host for directions and information.

Party size per Camp Site Space:

- Maximum of eight (8) people per camp site space for overnight stay
- Overflow parking is located north of the campground near the Fairgrounds buildings.

Vehicle Licensing:

- All vehicles, motorhomes and trailers (motorized or not), must be currently registered, licensed, fully operational, and in good working order.

Mobility of Trailer and/or Recreational Vehicle:

- Trailers and/or Recreational Vehicles parked for the purpose of storing is unlawful and prohibited. If a Trailer or RV is left unattended beyond its paid-for time period, it will be considered unlawfully abandoned and towed at the expense of the owner.
