MEETING CALL TO ORDER: The Special Workshop of the Port District of South Whidbey Island's Board of Commissioners and the City of Langley was convened on Wednesday, October 5, 2011, in the Langley City Hall Council Chambers at 112 Second Street in Langley, WA. As announced, the primary purpose of the Special Workshop was for review and discussion of the Port's proposed Phase 1 expansion of the South Whidbey Harbor at Langley by the City Council and Port Commission and Staff, along with other Harbor coordination issues. The meeting was called to order at 3:03 p.m.

DISCUSSION ITEMS:

Introductions: All Port and City representatives were introduced.

Review of 2007 InterLocal Agreement between Port and City: Arango read aloud his Memo to the Mayor and City Council dated September 28, 2011 (EXHIBIT A).

Presentation of Proposed Phase 1 of Harbor Expansion by Commissioner Jerome, with additional information from Commission and Staff: Jerome provided a 20-minute PowerPoint presentation (EXHIBIT B) that included Harbor Design Development History, Current Design, Proposed Phase 1 Construction and Future Phases through Final. Harbormaster Rick Brewer read aloud his prepared statement titled "A Viewpoint from the Harbormaster" (EXHIBIT C). Port Operations Manager Ed Field displayed drawings and provided explanations of various designs up to and including the current proposed project. He provided the City with copies of the "Proposed Phase 1 - \$2.5M" summary (including lists of First Year Benefits and Concurrent Activities), "Summary of Port Accomplishments for 2009-2011 and Proposed Phase 1 South Whidbey Harbor Improvement" and "Review of Port Commitments and Completions: South Whidbey Harbor Improvement & Expansion" (EXHIBIT D).

Comments and Discussion: City and Port representatives asked questions and made comments throughout the presentations. No action was taken and no decisions were made.
