Port Updates – Stan Reeves – Black box is mostly finish, refining a few last details. Coffman kitchen is moving forward, and plans will be done in February. Contracts will be completed in May and the construction will start after the fair with a planned finish of date January 2020.

The Port is working on the drainage issue in the horse arena. The next project will be the footing for the horse arena with a completion date of 1^{st} of April.

Virginia Keck -Island County Fair Association - No report

Langley Chamber of Commerce - Inga Morascini – The Langley C of C is working on events to bring people into the City of Langley and the fairgrounds. These events will increase revenue from tourism and show case Langley and the surrounding as a desirable location to visit.

- 1. Mystery Weekend, February 23rd & 24th
- 2. Working on a possible 2nd mystery event on the fairgrounds for youth next year, happening at the same time as the adult Mystery Weekend.
- 3. October Harvest Event, 1st week of October as the end of Whidbey Island grow week,
- 4. Lady Washington is coming to Langley in September 2019. Lady Washington is a replica of the first ship to explore Washington.
- 5. Orcas Whale seminar
- 6. Suva Antique sailing ship will be dock at Langley Harbor during the weekend of July 4th and again in August.

Gwendy Hastings – Member at Large – Doing research and found that the public likes Bingo, Sushi Event and Country Christmas. The public would like to see something every month on the fairgrounds.

The Port of South Whidbey - Stan Reeve — In the future, FAC will have involvement in creating the budget and the work will start earlier in the year. The Port will be re-naming the fairgrounds, to appeal to more individuals and groups who may be interested in renting the property.

Sharon Edwards – WWGA – Working on set dates for shows, generally the shows are on the 1st Sunday of each month. The gaming season starting April 7th, with all shows being 2 days shows with the exception of the September show.

Jon Beck – Member at Large – The port tractor delivered back from WA Tractor, but delivered to the wrong location by mistake. Repairs were made. Mr. Beck raised the following issues.

- 1. There is a need for a drag class for the horse arena, so everyone is following the same process, so liability issues don't develop.
- 2. The port needs to secure the proper equipment. The port has a pasture drag and not an arena groomer that is needed to groom the arena.
- 3. The footing isn't safe and needs to be address.
- 4. Roofs on the horse barns is in need of repair and can they be patched this year?

South Whidbey Historic Society - Gary Gabelein – Sharon Edwards, asked "If there can be a substitute for the appointed member of the FAC, when the appointed member is unable to attend the meeting?" There was no rule on it and the committee needs to have input from each of the groups. This day forward if you can't make the meeting, you must contact Stan and send a sub. One vote per group.
