**Port Update:** Stan Reeves gave a brief report on the current projects/status of the ongoing Port projects throughout the Port District. prepared for the upgrade of existing restroom facilities on the Fairgrounds. This is being paid for by a grant from the Washington State Department of Agriculture, funds from the Island County Rural County Economic Development grant, and Port funds. The intent is to have bid set plans prepared and ready for renovations if/when additional funding is available to execute renovations.

## General Roundtable:

**South Whidbey Historical Society, Chair:** Emphasized that the Port should encourage members to attend meetings; that the FAC needs the participation.

**4H:** The state 4-H coordinator issued guidance that guidelines for COVID-19 precautions will not be issued at the state program level; local 4-H programs will follow the guidelines in effect at local venues the guidelines issued by the Governor's office specific to "Fairs, Parades, Festivals, and Special Events". 4-H is still working the specifics on "how" to participate in Fairs and Shows; however, there is no requirement to offer "virtual" participation.

**Fair Association:** The state issued guidance to conduct "Fairs, Parades, Festivals and Special Events" on April 26. The Fair Association is expecting the Governor's office to issue new revisions for "Events" in the very near future. The Fair Association is still trying to coordinate with the Carnival vendor for the Fair; they want to have at least three events to support in NW Washington before committing. Also, the Fair Association is waiting to see participation numbers from the 4-H Spring Show in order to project 4-H participants in the Fair.

"Antique Barn". During the 2019 Fair, some folks were upset that they couldn't find the "Antique Barn" since no buildings were labeled in that way. The Fair Association suggested that as an alternative, they could supply a banner to hang on the building indication that it was the "Antique Barn".

**Dedication/plaques on buildings or facility:** This topic was the subject of considerable conversation. Highlights include:

- The Port will pay for the cost of plaques/engraving so long as the cost is reasonable.
- Size and exact type of plaques is still to be determined.
- Wording on the plaques is still to be determined; "wording" examples from the January 2020 will be disseminated at the June meeting for discussion.

The Fair Association reiterated that they preferred to have one of the Horse Barns named for "Marilyn Gabelein". Given that the FAC had previously decided to move forward with dedication plaques that could include multiple names, the Fair Association suggested compiling a small history on the individuals to include on the plaque.

## **New Business:**

Additional changes to the Bylaws were proposed; specifically, to change the day/time of meetings, add alternates to Permanent Organization representation, and adjust language throughout for consistency.
