Old Business:

Dedication/plaques on buildings or facility: This topic was the subject of considerable conversation. Highlights include:

- Size of the plaque will be 18"x24" and have capacity for 36 name plates.
- Plague will be black with silver lettering (majority vote)
- The first nameplate for the plaque will honor Marilyn Gabelein
- Wording on the plaques will be determined at the October meeting. The two final choices are:

"In recognition, with heartfelt gratitude, for their unselfish contribution and dedication to the Fairgrounds and our Community, this plaque is a token of our love and gratitude to honor and remember them for years to come."
